# **Operating instructions**NATRAS AG



### 1. Introduction to the operating regulations

- 1.1. These operating regulations are an integral part of the General Terms and Conditions (GTC) of NATRAS AG. They were submitted to the Federal Office for Customs and Border Security (FOCBS), which reviewed and approved them.
- 1.2. They regulate the commissioning and operation of the vehicle recording system (VRS) as well as the use of the Online-Service-Desk (OSD) and the failure solution (ALL).
- 1.3. The customer's conduct must comply with the requirements of the Federal Act on the Performance-Related Heavy Vehicle Fee (HVC) of 19 December 1997 in the version of 1 May 2024 or newer (SVAG; SR 641.81) and the Ordinance on the Heavy Vehicle Fee of 27 March 2024 in the version of 1 May 2024 or newer (SVAV; SR 641.811).
- 1.4. This includes compliance with all legal provisions on the performance-related heavy goods vehicle charge in order to ensure proper recording and invoicing of kilometers travelled.
- 1.5. The operating regulations cover the following areas:
  - commissioning and operation of the vehicle recording system (VRS)
  - use of the Online Service Desk (OSD) and the failure solution (ALL)
  - · obligations of the person liable to pay the tax to cooperate
  - obligations of the driver to co-operate
  - obligation to co-operate when commissioning NATRAS for foreign vehicles
- 1.6. Compliance with these operating regulations is essential to ensure the correct use of the systems and to fulfil the legal requirements of HVC legislation.

# 2. Commissioning and operation of the vehicle recording system (VRS)

- 2.1. **Instructions for commissioning and operating the VRS:** the vehicle detection system (VRS) must be installed and operated in accordance with the instructions in the vehicle detection system manual. It must be ensured that all steps for commissioning are carried out correctly in order to guarantee the functionality of the system. - 2.2. **Consideration of the regulations for ADR/SDR vehicles**: when installing and operating the vehicle detection system (VRS) in ADR/SDR vehicles, the relevant legal regulations must be observed. The operation must comply with the special requirements for the transport of dangerous goods as specified in the ADR/SDR guidelines. - 2.3. **Displaying and monitoring the functionality of the VRS:** the condition and functionality of the recording system (VRS) must be checked regularly and, if necessary, measures must be taken to ensure functionality. The corresponding indications of functionality are described in the manual for the recording system and can be viewed here: <a href="https://natras.ch/manual/esf/">https://natras.ch/manual/esf/</a>.
- 2.4. **Monitoring of functionality via the Online-Service-Desk (OSD):** the status and functionality of the VRS can also be monitored via the Online-Service-Desk (OSD). The functions required for this are described in the OSD manual and can be viewed here: <a href="https://natras.ch/manual/osd/">https://natras.ch/manual/osd/</a>.
- 2.5. **Availability in the mobile phone network:** within the Swiss customs territory, the VRS must be able to connect to the Swisscom mobile network at least once every 30 days. This is the only way to ensure proper automated registration with the FOCBS. If inactivity is planned for a longer period of time, a manual "registration of days without travelling" must be carried out in the failure solution. In the event of faults or failures, measures to restore the connection must be initiated immediately.
- 3. Operating instructions for using the Online-Service-Desk (OSD) and the failure solution (ALL)
- 3.1. Initial registration of keeper data: as part of the initial registration, the person liable to pay the levy is obliged to provide correct personal details. After approval, further agents can be added to the corresponding account. The person liable for payment is responsible for maintaining this data and keeping it up to date for the entire duration of the contractual cooperation. - 3.2. **Registration of the vehicle data:** once the account has been confirmed, the user enters the corresponding chassis number (VIN) in the Online-Service-Desk (OSD). This data is then transmitted electronically to the FOCBS and reported back with the corresponding status. The user is obliged to check all data entered, in particular the chassis number, for accuracy. - 3.3. **Foreign vehicles**: foreign licence holders who wish to use the services of the NNA require a permit from the FOCBS. This authorisation is a prerequisite for using the services offered and serves to ensure proper registration and compliance with legal regulations.



- 3.4. Ordering vehicle recording systems (VRS): for confirmed chassis number (VIN), the corresponding number of vehicles recording systems (VRS) can be ordered directly from the Online Service Desk. These are then delivered to the user during business hours within 48 hours of the following day. - 3.5. **Monitoring the functionality:** monitoring the status and ensuring the functionality of the vehicle recording system (VRS) is the responsibility of the person liable to pay the fee. This can be done via the Online-Service-Desk (OSD). - 3.6. **Use of the failure solution (ALL):** if the vehicle recording system (VRS) does not function correctly, the failover solution must be used. The deadlines described in chapter 4 must be observed for this. - 3.7. **Reporting defective vehicle (VRS) recording systems**: vehicle recording systems (VRS) that have been identified as defective by the user must be reported immediately to the Online Service Desk. Further steps must be followed in accordance with the provider's requirements. # 4. Obligations of the person liable to pay the tax to cooperate

- 4.1. **Installation and ensuring operational readiness:** in accordance with HVC legislation, the person liable to pay the fee is obliged to install the vehicle recording system (VRS) for the relevant journeys and to always keep it operational. Detailed instructions on installation, commissioning and subsequent operation are available in the manual at <a href="https://natras.ch/manual/esf/">https://natras.ch/manual/esf/</a>.
- 4.2. **Procedure in the event of a confirmed malfunction**: in the event of a confirmed malfunction of the automatic system, the person liable to pay the fee is obliged to use the specified failure solution. The corresponding journeys must be recorded within 10 calendar days after the journey. The functions required for this are described in the "Failure solution" section and can be viewed at <a href="https://natras.ch/manual/osd/">https://natras.ch/manual/osd/</a>.
- 4.3. **Correction of a recorded journey that is not subject to HVC:** the person liable to pay the fee is obliged to enter corrections such as registrations and cancellations of journeys

within 10 calendar days of the journey. The functions required for this are described in the chapter "Failure solution" and can be viewed here: <a href="https://natras.ch/manual/osd/">https://natras.ch/manual/osd/</a>.

- 4.4. Deletion of recorded registrations, additions and corrections: subsequent registrations, additions or corrections to journeys must be made by the person liable to pay the fee within 10 calendar days of the journey. The required functions are described in the chapter "Failure solution" and can be viewed at <a href="https://natras.ch/manual/osd/">https://natras.ch/manual/osd/</a>.
- 4.5. **Registration and recording of days without driving**: vehicles that are not in operation for a longer period of time must be recorded within 10 calendar days after decommissioning and up to a maximum of 90 calendar days in the future for a maximum of 30 days to avoid an assessment in the absence of registration in accordance with Article 51 SVAV. - 4.6. **Procedure for change of keeper with and without continued use of the VRS:** if the person liable to pay the fee intends to transfer a vehicle with or without a vehicle recording system (VRS) to another keeper registered with NATRAS, the instructions in the "Transfer" section of the Online-Service-Desk must be followed. - 4.7. **Decommissioning a vehicle recording system (VRS) that is no longer required:** if the VRS is no longer required, it must be deregistered by the person liable for the levy in accordance with the instructions in the Online-Service-Desk. - 4.8. **Returning VRSs that are no longer required:** vehicle recording systems (VRSs) that are no longer required must be returned to NATRAS in perfect condition within 14 days at the latest. # 5. Obligations of the driver to co-operate

5.1. Operational readiness of the vehicle recording system (VRS): the vehicle driver is obliged to keep the vehicle recording system (VRS) always operational for the relevant journeys. He must ensure that the VRS is working properly before starting a journey. - 5.2. The user is obliged to register or deregister the trailer type and the respective total weight with the VRS before entering the CUSTOMS AREA.
- 5.3. **Correct operation of the vehicle recording system (VRS):** the vehicle driver is obliged to operate the VRS in accordance with the instructions in the manual and to ensure that it functions correctly during the journey. Incorrect operation must be avoided to ensure the correct recording of mileage-related data. ### 6. Obligation to co-operate with foreign vehicles

- 6.1. Operational readiness of the vehicle recording system (VRS) before entering the customs territory: The person liable for payment acknowledges that when importing the vehicle recording system (VRS) into a country outside Switzerland or the Principality of Liechtenstein, statutory value added tax and a processing fee for customs clearance will be incurred.
- 6.2. The person liable for payment is obliged to ensure that the vehicle recording system (VRS) is installed in a foreign vehicle and put into operation before the vehicle enters the customs territory. The installation and activation of the VRS must not take place within the customs territory but must be completed before entry in order to ensure a correct recording of the journey data in accordance with the requirements of the HVC legislation.
